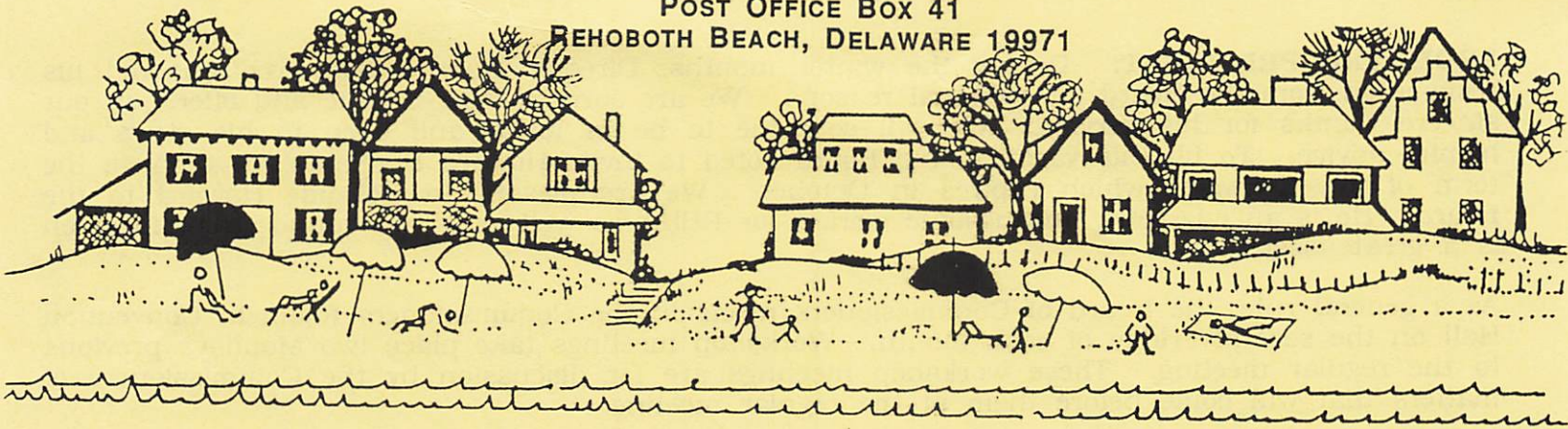

The RBHA was contacted by the Department of Natural Resources and Environmental Control of the State of Delaware and invited to co-sponsor a *GLOBAL WARMING ALERT FORUM* on April 27 at the Atlantic Sands Hotel. This forum was one of the scheduled events of Delaware Earth Day 1990 week. RBHA directors voted to join DNREC in this project and the department supplied several very interesting speakers. The RBHA is pleased to have been a part of this international effort to create long-term protection measures for our fragile environment.
