Thank you to the RBHA for letting me introduce myself. My name is Tim Bennett and I am the "newcomer" to city politics. I grew up in Connecticut and graduated from Marietta College in Ohio with a PR/Marketing degree. I have lived on both coasts and a lot of places in the middle. have watched every available City Government and Committee meeting online and even quietly attended a few meetings. The city has an engaged populace and a dedicated group of elected and appointed leaders. However. multiple over administrations the same issues continue to resurface and never seem to get resolved. While everyone running for office in the election is certainly qualified and respected, I bring a fresh set of ideas, eyes, and new energy that is unencumbered by the past.

When it was announced that I was a candidate for Commissioner in the City of Rehoboth Beach, I immediately received an email that asked if I was "pro-business or not?" I have often heard this question posed as if there is a "yes" or "no" answer.

"I am pro-Rehoboth Beach", is my response. That is not a dodge, it is an unambiguous fact. You cannot be pro-Rehoboth Beach without being for preserving the character of our quiet neighborhoods, supporting our businesses, and welcoming visitors. And I adamantly support all three elements.

One thing is for certain however; change is inevitable and we must plan carefully.

The biggest issue facing our city in 2021, and in the next decade, is growth and redevelopment. Managing growth starts with a shared vision, followed by definitive plans, smart execution, and then sensible refinement. I call this "Good-Growth" and it needs to start now. There are many projects facing the city in the near term and as the custodians for a short time we are at a critical juncture to make sure we get it right for the next generation.

Some of the components that comprise this "Good-Growth" Initiative are as follows: a completed and clear CDP, properly written and enforced Zoning Codes, an employed City Planner, and I recommend the addition of two committees: marketing/communication and architectural review. If you elect me, and put your trust in me, I will advocate for "good growth" while maintaining and improving on all that we love about the city. Change is inevitable. Plan carefully.

If re- elected I commit to continue to work collaboratively with other commissioners, the mayor, city commissions/committees, residents and businesses on important issues facing the city:


Preserving our neighborhoods – insure quality of life is maintained to a high standard, continue to improve infrastructure.

The top 3 issues facing Rehoboth:

Our Neighborhoods and Downtown in Harmony: The COVID pandemic dramatically impacted city revenues. increased expenses and debt, had a severe economic impact on our local businesses and property owners who rely on summer rental income to pay mortgages. At the same time, the flight from other cities has meant a vibrant real estate market and growth in full-time participation. residents. To foster full especially by our new homeowners, I would like to launch a Customer Experience Committee comprised of residents. organizations such as RBHA, and our local businesses to generate and freely discuss ideas and recommendations to keep our City moving forward positively.

During my tenure, I passed budget approval for a dedicated communications professional, ensured stronger financial discipline, championed a feedback mechanism for public input, and chaired the Mayor's Advisory Committee on Trees, which created a public-private partnership to enhance our standing as a Tree City using private donations. Additionally, I led the City Commissioners to unanimous consensus on our green infrastructure agreement.

I am running for a third term because I have very strong opinions on—

- Fairness for all constituents:
- Responsibility of public service; and
- Doing the right things for the City of Rehoboth Beach.

During my time in Rehoboth, I've seen and heard from a lot of people, and few have exactly the same perspective or interests – not all voters want the same things, not all businesses what the same things, and certainly visitors come here for different things. We need to do the right things for the City, which means we need to restore and redouble our efforts to balance the needs of the triad that keeps our City great—voters, businesses and visitors. We need to listen to the public and focus on "must have" projects versus "nice to have" projects.

As we head to the polls on August 14th, we need to remember the kind of leaders we need:

- We need leaders who will protect our natural assets –the beach, the boardwalk, the trees, and the lakes.
- We need leaders who will bring experience and knowledge to manage our tax dollars.
- We need leaders who conduct business in the open.
- We need leaders who ask our opinions, listen to us, discuss all points of view and then act in the interest of all our citizens.

My voting record from my two terms as a City Commissioner shows that I have all these qualities, that I understand the intricacies of complex issues the City must address and that I will work to find the appropriate balance between different interests and priorities.
